Buyer agrees to following conditions:

This contract is for original puppy, stated above, and is between original buyer and seller therefore is nontransferable to third party. The health and temperament of this puppy is excellent to the best of our knowledge and belief at the time of sale. The required vaccinations and worming are as indicated on the health record. We advise the Buyer however, to have the puppy examined by a licensed veterinarian of Buyers choice within 72 hours after receipt of the puppy. If the veterinarian finds the puppy to be in poor health, the buyer must notify seller immediately and must include all documentation from veterinarian. The puppy MUST be altered, and proof given to breeder. This guarantee is for a replacement puppy of equal value unless other arrangements are mutually agreed upon. Failure to see a veterinarian within 72 hours will void all guarantees. This does not include umbilical hernia, undescended testicles, or allergies.

We recommend spay/neuter after 14 months. If said puppy is spayed/neutered prior to 14 months all guarantees are VOID.

If the puppy becomes sick, is injured, or dies or has to be put to sleep for any reason other than those stated in the guarantee after the initial 72-hour period, the seller has no obligation to replace the puppy and will be relieved of all responsibility to do so. The buyer agrees to relieve the seller of any and all liability with the puppy. It is Also agreed that the seller is relieved of any, and all future liability of all kinds associated with the puppy/dog. This constitutes the full agreement of the parties. There are no guarantees or Warranties either expressed or implied beyond what is stated in this contract.

Our puppies are guaranteed for 2 years or until puppy reaches age of 26 months (to submit x-rays to OFA for certification) for any genetic problems that would keep the puppy from living a normal and healthy life, this also includes crippling hip or elbow dysplasia confirmed by x-rays from a competent licensed veterinarian. The Buyer agrees to maintain preventative care of the puppy/dog in regards to hip dysplasia and overall health, such as proper nutrition, proper exercise, and preventing stress injuries. If this puppy/dog develops crippling hip dysplasia at any time from purchase to twenty-six months of age (confirmed by X-rays from a competent licensed Veterinarian and the Veterinarian confirms that the puppy/dog has also been given proper care) the puppy/dog shall be returned to the Seller at the expense of the Buyer, unless the Buyer wants to retain the puppy/dog. Should the Buyer prefer to retain said puppy/dog, the Buyer thereby forfeits any replacement, unless other arrangements are mutually agreed upon. The Seller will replace the puppy/dog (due to

crippling dysplasia) as soon as possible with a replacement of equal value to the puppy/dog at the time of original purchase and only after the Buyer supplies documentation that the puppy/dog has been spayed or neutered. The Seller reserves the right to request that the X-rays be sent first for review to a board-certified Veterinary Radiologist or other Veterinarian of the Seller's choice.

If the replacement dog is found to have any genetic hip or elbow dysplasia, no further replacement dogs will be offered. The breeder is not responsible for veterinary fees and no monetary refunds will be issued.

No further guarantee is made.

The Buyer agrees to keep this puppy in a clean and pleasant environment, with proper nutrition, health care, and companionship. Under no circumstances will this puppy be sold, leased or given to any pet shop, research laboratory, shelter or similar facility. The puppy must reach a minimum age of 2 years before being bred (both Male and Female). If said puppy is bred prior to 2 years of age and passing OFA/Penn hip certified hips/elbows will cancel any breeder guarantees and no replacement dog will be offered

Buyer agrees that if at any time the puppy can no longer reside with her/him, seller will be given first option to take back the puppy. If seller cannot take said puppy, a mutually agreed upon home will be found. Buyer agrees to house puppy until mutually agreed home can be found. This puppy will not be surrendered to any animal shelter. Buyer Initial\_\_\_\_\_

Registered name of said puppy must end in "vom redriverk9" when registered with AKC/UKC.

Buyer agrees to pay for all expenses related to the flight if shipped by air, the health certificate and vet check, and a crate furnished by Seller. All expenses must be paid in full prior to shipping. Costs are paid up front prior to shipping or the dog will be held until funds are received. Buyer agrees that if funds are not received by the time the dog turns 8 weeks of age, buyer forfeits all rights to the dog, the dog will be sold, and all monies paid by the buyer will be retained by Seller unless other arrangements are made. Additionally, Buyer agrees to pick up the puppy or have the puppy shipped no later than 8 weeks of age. Puppies that stay later than 8 weeks of age will be charged \$20 a day boarding fee until the dog turns 10 weeks of age at which time buyer forfeits all rights to the dog, the dog will be sold, and all monies paid by the buyer will be retained by Seller unless other arrangements are made.

All sales are final, and down-payments are non-refundable. The Seller does not guarantee the size, appearance, temperament, and personality of said puppy after it leaves the kennel or as an adult. The seller is not responsible for the outcome of the bonding process and experience with the new owner and will not be held accountable in any way or form for the behavior of the puppy after it leaves this kennel.

Buyer(s) agrees that they understand this contract, and that this contract is under the jurisdiction of the State of Tennessee; Rutherford County; Smyrna, Tennessee. All

legal issues and court proceedings will be resolved under Tennessee State Law. Internet sales and sales in person are included in this contract. This is a legal contract between buyer and seller.
